Before fintech, Nick was North America CEO of video games business Jagex and worked on facial animation AI that won an Oscar for The Curious Case of Benjamin Button and powered Rockstar's GTA V among many other globally renowned consumer franchises.

Phil was previously Chief Operating Officer at Nutmeg which was acquired by JP Morgan for £800m. He subsequently became Managing Director at Embark (+£50 billion in assets) which was acquired by Lloyds Banking Group for £400m. Phil also has a wealth of experience in investment banking, private banking and wealth management at Barclays and Lloyd's of London.

In 2012, Ricky also co-founded Azimo, a digital payments platform powering money transfers to over 190 countries in 70+ different currencies. Azimo was acquired for 9-figures by Papaya Global.


